

## **Seeking suggestions/inputs for enhancing the value added by the Background Material on GST published by GST & Indirect Taxes Committee of ICAI**

The GST & Indirect Taxes Committee has initiated the revision exercise of its flagship publication, **"Background Material on GST"**. The Background Material (BGM) on GST is a comprehensive publication containing detailed discussion & in-depth analysis of GST law. The first edition of this publication was released in July 2016 and since then it is being revised regularly.

Considering that it has been more than seven years since the BGM on GST was first published and there have been significant changes in GST law during this period, the Committee has decided to undertake an extensive revision of this publication to make it more useful for the readers. The Committee greatly values the feedback of the readers since it is they who ultimately use the publications. Accordingly, it has been decided by the Committee to reach out to all the readers and request them to contribute in enhancing the value of the Background Material.

The Committee welcomes specific suggestions aimed at improving the overall quality of the BGM. The readers can suggest additions/deletions in the existing content, add new content or point out errors, if any, in the BGM. It will be appreciated if the modified content is shared after incorporating the suggestions. To encourage readers' participation in this exercise, it has been decided to acknowledge their contribution by giving them a complimentary copy of the revised edition of the BGM.
